AFTERCARE POLICY

This policy must be read in conjunction with the POPIA Manual.

Purpose of the Policy

To provide an overview and guidelines for the procedures at Cec trwood School Aftercare. Cedarwood Prep School Aftercare is operated by Cedarwood School and Frovioes an all-inclusive, safe, and caring environment for your children. No food is provided. Parents via need to provide extra lunch/snacks for aftercare should their children require it.

Children are always cared for in a controlled, struct, red, and loving environment. Only adults designated by the parent/guardian may collect. Stercare children. Homework supervision will be done within a small group setting. Should a parent be late in collecting their child (after 18h00) on three occasions, their place in Aftercare may bottorteited.

One month's written/emailed notice is equired should you wish to withdraw from Aftercare.

Important to note: All staff are F. st Aid qualified.

The annual cost of Afterca. is divided over 11 months (January to November); therefore, you will be charged for the months that your child is not at aftercare in order to alleviate a much higher monthly rate over fewer months (i.e. holiday periods).

No child will be released from Aftercare without a designated adult signing the child out. Please communicate with our caregivers at aftercare as to who the adult(s) are. Any change of collection time/adult needs to be communicated timeously, please. Collected children may not sign their siblings (or any other child) out of Aftercare.

Parents are to supply the names and contact numbers of any other people (apart from the parents above) who may be likely to collect your child from intercare.

Parents are to give details of any medical condition that your child has that the Aftercare needs to be aware of.
